皇田無衝突金屬採購政策與承諾

日期：2013年8月29日

電子工業公民聯盟(EICC)指出，部份金屬礦產已成為非洲剛果民主共和國武裝叛亂團體的主要財源，用來交易軍火、延續其與政府間的血腥衝突、蹂躪當地平民，因此引發國際爭議。

來自剛果民主共和國衝突礦區之礦物，礦物類別包含鈮鉭鐵礦(鈮鉭鐵礦)、錫石、黑鎢礦與黃金等。而這些礦物被提煉成鈮(Ta)、錫(Sn)、鎢(W) (簡稱三T礦物)、鈷(Co)、金(Au)等，分別用於電子及其他產品中。

因應電子工業行為準則(EICC)新增項目-衝突礦產如上，皇田工業身為世界公民，基於企業社會責任與尊重國際人權，我們宣示並承諾不接受使用來自衝突礦區的金屬。同時，也要求皇田的供應商：

- (1) 必須履行社會環境責任
- (2) 確保產品不使用來自剛果民主共和國及其周圍國家和地區的衝突礦產
- (3) 追溯所有產品中所含的鈮(Ta)、錫(Sn)、鎢(W)和金(Au)來源，所有供應商均應完成填寫調查表及宣告(請下載“無衝突金屬報告模板”)，已回覆的供應商不須再填寫
- (4) 將此要求傳達給貴司的上游廠商

Macauto Policy and Commitment of Metal Conflict-Free

Reported by Electronic Industry Citizenship Coalition (EICC), partial minerals have become the Democratic Republic of the Congo's main revenue sources of armed rebel groups, to deal in arms, continued its bloody conflict between government forces, devastated the local civilian population, thus triggering international disputes.


The minerals composed of columbite-tantalite, cassiterite, wolframite and gold from the fighting region of Democratic Republic of the Congo (DRC). These minerals are refined into tantalum (Ta), tin (Sn), tungsten (W) (referred to as the 3 T's), cobalt (Co) and gold (Au), respectively, and are used in electronics and other products.

For Conflict Minerals as above added by Electronic Industry Code of Conduct (EICC), Macauto, as the global citizen, respects human rights and embraces its Corporate Social Responsibility, we declare and commit to refusing the application of metals from fighting region; meanwhile, we request Macauto's supply chain:

- (1) Conduct your operations in a way of social and environmental responsibility;
- (2) Not use the conflict minerals originated from the Democratic Republic of the Congo (DRC) and its adjoining countries;
- (3) Trace the origins of the metals used, e.g. Ta, Sn, W and Au, and fill in the investigation form and sign declaration (Please download "Conflict Minerals Reporting Template"). If you have completed the latest survey form before, there is no need to reply again;
- (4) Make the same requirements to your upstream suppliers.
